



He earned great wealth due to hard work and polite behavior. He purchased shares in companies. Later he also took in hand the trade of jute and became known as the Jute King. He was a strong believer in God. He spent a lot of money in social welfare works. He started many hostels, libraries and dharamshalas. He floated scholarships for financially weak and needy students. He financed higher studies of Sir Chhotu Ram. He was known as Bhamasah of kshatriya caste. The British government awarded him the title of 'Sir'.



ABOUT THE UNIVERSITY

University is named after great environmentalist, Guru Jambheshwar Ji Maharaj. Guru Jambheshwar University of Science & Technology started its journey on 20th October, 1995 at Hisar, Harvana. The University was established under the Act of State Legislature that facilitates excellence in teaching and research in promising areas of higher education with focus on new frontiers of Science & Technology, Engineering Studies, Environmental Studies, Media Studies, Pharmaceutical Sciences, Management Studies, Yoga Science, Physiotherapy, Humanities and Social Sciences and also to achieve excellence in these related fields. The University has achieved several milestones since its establishment. The University is duly recognized by the University Grants Commission (UGC) under Section 2(f) for recognition of degrees on 11.1.1996 and under Section 12(B) of the UGC Act was eligible for central assistance on 7.2.1997. Today, the University spreads over 372 acres of lush green land with 9 mammoth Teaching Blocks, 22 Teaching Departments classified under 10 Faculties which houses 55 Regular programmes on campus and 24 programmes through Distance mode along with Ph.D. degree programmes in all its Departments. These Distance Education programmes stand approved by Distance Education Bureau, UGC. The National Assessment and Accreditation Council (NAAC), has accredited this University at 'A' Grade three times consecutively since 2002 and extended upto Dec. 2021. In addition to this, the University has been ranked 88th among the Universities/Institutes and 27th Rank in Pharmacy in India as per National Institutional Ranking Framework (NIRF) in 2021. The University has also been ranked in band 1001-1200 in the Times Higher Education World University 2022 and in band 251-300 among ASIA University ranking 2021. The University has been granted graded Autonomy and UGC has placed it in Category-II University. It is one amongst the 21 State Universities of the Country to have achieved this position. This University has also been admitted for the 3rd time for Global Initiative of Academic of Network (GIAN) Phase-III Scheme, a prestigious scheme of MHRD (MOE). The University has been sanctioned 50 Crore as grant by RUSA. The University has received prestigious Indian Education Excellence award, 2018 by Berkshire Media Pvt. Ltd., LLC, USA and our University was the only University to pocket this accolade from North India under Engineering Science and Technology Category. The University has been ranked 321st World's Most Sustainable University in 2019 in UI Green Metric World University Rankings announced by University of Indonesia, Jakarta. The University has been awarded 1st Prize at State level for spreading awareness about "Prevention of Alcoholism and Substance (Drug) Abuse". The efforts of the University are recognized by the Social Justice and Empowerment Department, Government of Haryana by rewarding it with a cash prize.



Recognising the selfless services of Seth Chhaju Ram, the Managing Committee of Jat High School started Chhaju Ram Memorial Jat College in July 1967 and Chhaju Ram College of Education in 1969 in loving memory of Seth Chhaju Ram. 

BUILDING

Eligibility Criteria

A person who has passed LLB 3 years Programmes or B.A. LL.B. 5 years programme or an Equivalent programme duly recognized a UGC-Approved University with at least 50% marks (45% marks for SC/ST) aggregate, shall be eligible to join LL.M. Course.

LL.B. 3 YEAR (PROFESSIONAL) COURSE

The LL.B. (Professional) course is of three year duration with 6 semesters examination system.

Eligibility Criteria

Bachelor's Degree or Master's Degree Examination of the GJUS&T or any Examination recognised as equivalent thereto, with English as one of the subjects in the qualifying examination and with atleast 45% marks in the aggregate 40% for SC/ST candidates (as per Bar Council of India requirements) in either of these Degree (One-Year Degree/Diploma Courses like, D.P.Ed., M.Ed., B.Ed., B.Lib. Sc., etc. shall not be considered as equivalent to Bachelor's Degree).

B.A. LL.B. 5 YEAR INTEGRATED COURSE

B.A.LL.B. 5 year integrated course is of 5 years duration with 10 semesters examination system.

Eligibility Criteria

- a) A candidate who has passed Senior Secondary Certificate Examination (10+2 standard) from The Board of School Education Haryana or an Examination recognized as equivalent thereto, with 45% marks in the aggregate with five subjects **including the subject of English** shall be eligible to seek admission in the first semester of B.A.LL.B (Hons.) 5 Year Integrated Course. Explanation: The candidate who have obtained 10+2 through Open University System directly without having any basic qualification i.e., Matric/Secondary/10+2 are not eligible for admission in the B.A.LL.B. (Hons.) 5-Year Integrated Course.
- b) The minimum eligibility condition in the case of SC/ST Candidates shall be 40% marks in the qualifying Examination with **English as one of the subjects.** (There shall be no rounding of percentage of marks of the qualifying Examination i.e.40% and 45% means exact percentage. Thus 39.5% and above does not mean 40% and 44.5% above does not mean 45%).
- c) All Courses are open only to whole time students and not to employed or self-empolyed.

Note: CANDIDATES HAVING COMPARTMENT/RE-APPEAR, IN THE QUALIFYING EXAMINATION SHALL NOT BE ALLOWED ADMISSION TO ANY OF THE COURSE EVEN PROVISIONALLY.

ADMISSION PROCEDURE

Admission Procedure

The Admission in B.A.LL.B. (5 Year), LL.B. (3 Year) & LL.M. shall be made on the basis of Merit of Qualifying Examinations as per rules & other terms and conditions of the GJUS&T, Hisar. Candidates have to apply online application form for admission in B.A.LL.B. 5 years course, LL.B 3 years course and LL.M. 2 years course on the college website i.e. **www.crlawcollege.com**

Reservation, Distribution of Seats for B.A. LL.B. 5 Year Course, LL.B. 3 Year Course & LL.M. 2 Years Course For the Purpose of Reservation of Caste (SC, BC, DAP, EWS & Ex. Service Man and their dependents) the list mentioned by GJUS&T and latest reservation policy of Govt. of Haryana to be notified by Haryana Govt. from time to time.



It is further stated that:

The Scheduled Caste students of Haryana whose family income from all sources is upto Rs. 2.5 lacs per annum as prescribed by the State Govt. for Post Matric Scholarship and who produces, at the time of admission, the "Caste" and "income" certificates issued by the competent authority, are not required to pay Fees/Fund and they may pay a sum of Rs. 2000- (Refundable) as security/caution money at the time of admission. The eligible SC students will apply the Post Matric Scholarship Form on the concerned Portal. The fee will be deposited from her/his scholarship amount as and when they recieve the scholarship in their account through DBT. In case the student does not apply for scholarship or is found ineligible for award of scholarship or being eligible she/he is not awarded scholarship due to one or the other reason and not deposited fee she/he will be liable to pay full fee, along with late fee @ Rs. 10/-per day.

- 2. The candidates must read the Online prospectus and guidelines carefully before filling the Online Admission Form. Self Attested copies of the certificates / documents are to be uploaded with the Admission form. Photographs & Signature must be uploaded with the Admission Form. Proof of Original Migration Certificate be uploaded if the candidate has passed his/her 10th,10+2, B.A, M.A. or any other examination, other than from GJUS&T.
- 3. Nothing contained in this Online prospectus would be construed to convey sanction or cited as an authority for which University Regulations in Calendar Vol. I, II and the relevant Rules in Vol. III, alone are applicable.
- 4. If the concerned authorities are not satisfied with the character, past behaviour and antecedents of a candidate, they may refuse to admit him/her to law course in order to ensure academic standards, discipline and peaceful atmosphere in the College. The Vice-Chancellor may cancel the admission of any student on the recommendation of the Principal/Director of the College.
- 5. The Application Form must be submitted Online on www.crlawcollege.com.
- 6. Late or incomplete application or document(s) submitted on the prescribed mode will not be considered and no further correspondence will be entertained in this regard.

WEIGHTAGE

In view of the Letter no. ACM-3/Adm -13/07/8310-509 dated 21-5-07 the weightage for the purpose of merit for Law courses, shall be prepared in the following way:

Weightage for the Purpose of Merit for B.A. LL.B./LL.B. Courses /LL, M. 2 Years Degree Course

Candidates who are eligible for admission will be entitled to weightage as given below:

(A) Candidates who have passed the qualifying examination from the Universities in the Haryana State : 5 Marks
 (B) Recipients of National Talent Award from the N.C.E.R.T. : 5 Marks
 (C) Candidates who have secured 60% marks/CGPA 6.0 on 10 point scale from First Public Examination : 5 Marks

(C) Candidates who have secured 60% marks/CGPA 6.0 on 10 point scale from First Public Examination : **5** to Qualifying Examination.

(D) N.C.C. Codete who have record (D) Co.

(D) N.C.C. Cadets who have passed 'B' Certificate and; : **3 Marks**N.C.C. Cadets who have passed 'C" or "G-II" Certificate : **5 Marks**

(No weightage will be given for Civil Defence Service).

Note: If a NCC Cadet have 'B' & 'C' Certificates maximum weightage of 5 marks will be given.

Students who have been recommended or commended (i.e. have obtained 1st or 2nd position) at the Inter-Zonal or Inter-University or Inter-State or State Level Youth Festival(s) or competition(s) either individually or as members of a team. **OR**

Sports persons who have won 1st or 2nd or 3nd position at the University/State level Tournaments organized by the State Govt./Haryana Olympic Association/ University in individuals events or Team games or have actually participated in Inter-University or National level duly recognized by Association of Indian Universities/concerned National Federation/ Indian Olympic Association in the games in which Inter-University Tournaments are organized by Association of Indian Universities.

Holder of Certificate of Merit for N.S.S. awarded by the University.

Criteria for award of University N.S.S. Merit Certificate will be as under:

- 1. N.S.S. Volunteer who has completed 240 hours of regular activities in the period of two years and attended one annual special Camp (of at least 10 days duration) and
- 2. One who has donated blood at least twice or has made at least four illiterate literate. This shall have to be certified by the Principal alongwith the names and addresses of the illiterates or has shown exemplary act of courage or bravery by saving life like drowning, fire, natural calamities or man made calamities. In case of-N.S.S. Volunteers from other Universities located outside Haryana, one has to become eligible by way of becoming at par with the condition as required under Sr. No. 1 and 2 of the above criteria laid down for University Merit Certificate.

N.S.S. weightage will not be allowed to the students who have only N.S.S. participation certificate given by the College Principal.

For the students instructors/volunteers of Colleges maintained/recognised by the GJUS&T for running Adult Education Centres/engaged under M.P.F.L.

(The above weightage under Adult Education Scheme will be given on the basis of the Certificate issued jointly by the Principal of the College affiliated or maintained by GJUS&T and Hony. Director, C.A.C.E.E., GJUS&T, Hisar.

Provided that:

- (a) The weightage of marks for the purpose of the merit will be added to percentage of marks of qualifying examination.
- (b) The total weightage for merit (A to D) above shall not exceed 10 marks.
- (c) The weightage for the purpose of merit under Clause (D), shall be given only if the candidate has obtained required certificate/Distinction during the entire course of the qualifying examination on the basis of which he is seeking admission to the course. For example, if a candidate is seeking admission on the basis of B.A./B.Sc./B.Com. Examination, he will be given weightage under this case only if he has obtained certificate of distinction, during I, II & III of B.A./B.Sc./B.Com. Course. Issued by properauthrity.
- (d) Weightage for sports will be given only in respect of Tournaments in the following games/events arranged by the University/Inter-University Sports Board or by a State/ National Organisation. No Game or event which is not recognised by the Association of Indian Universities shall be considered.

Games for Boys and Girls:

Athletics including Cross Country; Badminton; Basket-ball; Cricket; Cycling; Gymnastics; Hockey; Kho-Kho; Shooting; Swimming including Water-(Polo and Diving; Tennis; Table-Tennis; Volley-Ball; Hand-Ball; Kabaddi of National Style; Football; Chess; Boxing; Judo; Weight Lifting; Yoga; Best Physique; Wrestling; Power Lifting; Korfball, Softball and Net-ball.

CERTIFICATES

CHARACTER CERTIFICATE

Character Certificate is essential and Admission Forms, NOT accompanied by Original Character Certificate shall not be accepted. The details of character certificate to be furnished shall be as under:

(a) Private Candidates : Candidates who have passed the qualifying examination as private candidates should submit their

Character Certificate duly signed by a First Class Magistrate/Notary Public.

(b) Gap in Study : Male candidates who have gaps in their academic career after the Qualifying Examination, must furnish a **gap certificate in the form of affidavit** or certificate from the employer and should also

furnish a **gap certificate in the form of amuavit** of certificate from the employer and should also furnish separately Character Certificate of gap period from a First Class Magistrate/Notary Public.

(c) Regular students : Candidates who have passed the qualifying examination as regular students of session 2025-26

must submit the Original Character Certificate from the Head of the Institution last

attended as per specimen attached.

Other Certificates

At the time of seeking admission and applying online, following documents are required to be submitted:-

- (a) Certificate of Last Public Examination passed.
- (b) Self attested copy of certificate showing marks obtained and maximum marks in each subject of all the Years in the last Public examination.
- (c) Self attested copy of Matriculation of equivalent examination certificate in support of date of birth.
- (d) Original Migration/Transfer Certificate.
- (e) Self Original Character Certificate (as mentioned above).
- (f) Self attested copy of Certificate of distinction in Sports, if any.
- (g) Self attested certificate in case of candidates belonging to Scheduled Castes/Backward Classes (Block 'A' and 'B') / DAP/EBP Ex-Serviceman, DSC/EWS if applicable.
- (h) Self attested copy of Residence Certificate in the case of candidates claiming to be bona fide residents of Haryana, if applicable.
- (i) Four recent passport size coloured photographs.
- (j) Self attested copy of Differently Abled Person Certificate.
- (k) Parivar Pehchan Patra (Family ID).
- (I) Income Certificate.



Candidates selected for admission will be required to pay their full fee and other charges at the time of admission and if any candidate failed to do so his/her seat will be offered to the next candidate.

IMPORTANT NOTES:

- 1. Admission form received (either complete or incomplete) after the last date and specified time (as the case may be) for the purpose shall not be considered under any circumstances.
- 2. If the last date for receipt of admission forms falls on a holiday or that day is declared holiday by the University, the next working day will be considered as the last date for the purpose.
- 3. No individual intimation will be sent to the candidates for admission purposes. All candidates must find out their merit position in the Merit list displayed on the Notice Board of the Chhaju Ram Law College, Hisar on the prescribed date & time and website of college.
- 4. The candidates seeking admission for a particular category must be present in the Chhaju Ram Law College, Hisar according to schedule. The admissions will be made on the spot and dues will be accepted at the same time. Therefore, the candidates must bring with them the dues to be paid by them.
- 5. The candidates must bring with them their all original documents on the date of admission.
- 6. All entries in this form must be made by the candidate.
- 7. The Application Form must be completed in all respect. No column should be left unfilled. If any information sought is not applicable to the Candidate, the words "N.A." should be entered against that column.
- 8. A number of documents like copies of University/Board certificates, photographs, certificates claiming special status, etc. need to be uploaded with application. Without the required documents being attached, the application is liable to be rejected as incomplete.
- 9. All copies of University / Board Certificates, Photographs and character certificate etc., must be attested by the Head of the Institution last attended or by a Class-I Gazetted Officer or by an Officer of the University not below the rank of Assistant Registrar /Notary Public. The full name of the attesting Officer and the official seal must be clearly legible on the certificate.
- 10. A candidate appearing in the counselling cannot claim admission if found ineligible on verification of documents/certificates at stage of admission or at a later stage.
- 11. If the admission authorities are not satisfied with the character, past behaviour and antecedents of a candidate, he/she may be refused admission to LL.B./B.A.LL.B./LL.M. course in order to safeguard academic standards and ensure discipline and peaceful atmosphere in the college, The Principal on the recommendation of admission committee may cancel the admission of any student.
- 12. A student of B.A.LL.B./LL.B.(Professional)/LL.M. course shall not be allowed to take admission simultaneously in any other course.
- 13. It shall be the responsibility of the candidates to remain in touch with the college and to ascertain the progress of admissions. They should not wait / depend on receipt of communication from the college.




